



## Fine Arts in the Hills Call to Artists

The Hill City Arts Council (HCAC) is sponsoring the Fine Arts in the Hills Show & Sale this summer. This juried event was previously called Sculpture in the Hills however, this year we are growing the event to include flatworks along with sculptures. We will be joining with even more fine artists from around the country for a showcase of dynamic art. The event will be held on June 17-19, 2022 in downtown Hill City, SD.

We seek works that fall into categories that require highly developed techniques and skills. Examples may include, but not limited to, two dimensional arts like drawings/pastels, mixed media 2D, paintings, photography, and printmaking and three dimensional arts like clay, fiber, glass, jewelry, mixed media 3D, sculptures and wood.

Please accept our invitation to apply to participate in the Fine Arts in the Hills Show & Sale. This juried event is sponsored by the Hill City Arts Council, a non-profit organization serving our community. Our mission is to enrich the cultural life of the area by nurturing and supporting excellence in the arts; and by providing opportunities for area citizens, students and visitors to experience the arts in its myriad of forms.

### **Event Information – Please read carefully and in full**

#### **Space information:**

1. The Show tent is provided by the HCAC and is set-up on Elm Street in downtown Hill City. We provide one eight-foot table and two chairs. Artists may bring backdrops, displays, additional furniture, pedestals and other equipment for their space. No pipe and drape is provided.
2. Each exhibit space is 10' x 10'. Artists may choose to share this space with another artist. Each artist must be juried.
3. Space is assigned prior to the artist's arrival. Only the work of the artist(s) may be displayed and sold.
4. Artists may exhibit as many pieces that will fit into their space.
5. It is recommended that artists show their own work. Individual dealers or agents may stand proxy for artists.
6. Artists must be in their space during the **Artists' Reception, Friday, 6pm – 8pm; and show hours on Saturday, 10am – 6pm and Sunday show hours from 10am – 4pm.** Artists may not tear down their space until close on Sunday, 4:00pm.
7. The HCAC is unable to accept responsibility for lost, stolen, or damaged items. Security will be provided overnight.

## **Jurying Art: New Artists Only**

1. There is a non-refundable \$25 jury fee to be sent along with the Jurying Application.
2. Send four photos of your work for jurying review to Hill City Arts Council at [info@hillcityarts.org](mailto:info@hillcityarts.org) or mail to P.O. Box 321, Hill City, SD 57745. Along with the photos, please include a description of your art. Images will not be distributed or reproduced by the HCAC without permission from the artist(s), except for use in HCAC and Fine Arts in the Hills Show & Sale promotions.
3. No applicant can be accepted without going through the jurying process. Acceptance is at the discretion of the jurors and the HCAC. If it is determined that the artist's product is not handcrafted, the vendor may be asked to leave. Artists will be notified of acceptance within a few weeks after the receipt of the application.
4. Submit your artist bio, website URLs, and a brief description of artwork to: [info@hillcityarts.org](mailto:info@hillcityarts.org) by April 1, 2022. This is used in marketing materials at the event.
5. The Show's selection of an Artist confirms the commitment to exhibit.  
**NO REFUNDS will be made after May 16, 2022.**
6. Artists agree that the work they exhibit will be of the same type as the images submitted for jury by the HCAC.
7. Artists will be notified of acceptance and will complete the Participating Artist. Application.

### **Fees:**

1. 10 x 10 Space fee is \$350.00 and is to be submitted with the Participating Artist. Application to Hill City Arts Council, P.O. Box 321, Hill City, SD 57745.

### **Payments to artists:**

1. The HCAC will collect all payments for purchases (3% purchasing fee on all credit card sales will be added). HCAC is responsible for collecting and reporting SD sales tax.
2. For artists that have one 10' x 10' space, the first \$500 of sales will not have any commission paid to HCAC. For artists that have two 10' x 10' spaces, the first \$850 of sales will not have any commission paid to HCAC.
3. The HCAC will retain 25% commission on sales over the \$500/\$850 (based on space size). For example, an artist that has one 10' x 10' space and sells \$5,000 in total sales will pay 25% commission to the HCAC on \$4,500. The HCAC commission is \$1,125. For an artist that has two 10' x 10' spaces and sells \$5,000 in total sales, the 25% commission paid to the HCAC is calculated on \$4,150. The HCAC commission is \$1,037.50.

### **Set-up/Tear down:**

Artists may set-up on Friday, June 17, 2022 between the hours of 8am and 4pm. The Artists Reception is Friday at 6pm to 8pm. Tear down is Sunday after 4pm.

### **Pets:**

For safety and health reasons, pets will not be allowed at the Fine Arts in the Hills Show and Sale. Your personal pets will not be allowed in your booth. This does not apply to dogs used by law enforcement or for those with proper service dog identification and certification.
